Donna LaPietra, Chair and President, Millennium Park Foundation Millennium Park opened in 2004 to very different world than the one we live in today. In 2020 and through this year we have all been affected by a brutal pandemic. Millennium Park was not exempt from the effects of COVID-19. Like the human spirit, Millennium Park has adapted to today's challenges and has continued to thrive. Facing what seemed insurmountable obstacles, Millennium Park overcame the challenges of 2020 and remained as Chicago's free and open cultural space for all to enjoy.

Despite Millennium Park's closure from March until June, incredible work happened behind-the-scenes. Considerable work was accomplished as part of the Park's arboriculture program, including the pruning of all trees along Michigan Avenue and the main entrances to the Park. The Park's landscape received additional attention with the completion of the new North Gardens. And, Lurie Garden received extra attention during the flowering of spring bulb display.

Millennium Park safely re-opened in June as Chicago entered a less restrictive phase of pandemic mitigation. Mask wearing, metered entry, and limited access to certain artworks allowed the public to enjoy the Park throughout the remainder of the summer, fall, and winter. While no in-person programs occurred, the Park served as a beautiful space for visitors to experience physical and mental healing. The Great Lawn opened, and social distancing circles were created for guests to enjoy.

Millennium Park Foundation ventured into new horizons in 2020 — online virtual public engagement. Building on the partnership between the Foundation and the School of the Art Institute of Chicago, students from the School developed, directed, and delivered a virtual arts engagement event featuring the work of Edra Soto and Christine Tarkowski. Works by Edra and Christine are on display in the Park's Boeing Galleries through Spring 2023. Continuing the rich tradition of summer music festivals, Millennium Park created virtual festivals and programming in lieu of in-person events. The *Millennium Park at Home* series welcomed a diverse set of artists to perform for virtual Jazz, Blues, House, and Gospel Festivals. Chicago Children's Choir, Grant Park Music Festival, a special Music Series, and Summer Workouts occurred virtually as well.

Another highlight of 2020 was Millennium Park's winning of two prestigious awards. In September, Millennium Park was awarded the American Society of Landscape Architects' 2020 Landmark Award. This award recognizes a public landscape project that has both maintained its design excellence and helped to redefine public park and public space projects. In December, the Park was awarded a silver medal for the World Urban Parks, International Large Urban Parks Award. This silver medal recognizes the Park as one of the best all-around public parks in the world.

Millennium Park continues to set new standards for public space design and landscape as well as arts and culture activities, and all thanks to the vision and generosity of you — our Founders of Millennium Park. I thank you for your continued support of Millennium Park Foundation. Your support has helped see the Foundation and Millennium Park through a year unlike any before. We are proud to call you a partner with Millennium Park Foundation. Together, we will continue to adapt, create memories, and enrich the lives of Chicagoans and visitors alike.


### Landscape Excellence


